 - 7.1. Curtin University Divest from Fossil Fuels

Motion: That the Guild demands that Curtin University divests from and ends its business partnerships with fossil fuel companies. That the Guild endorses the divestment campaign launched by Uni Students for Climate Justice. That the Guild will investigate any ties that it has to fossil fuel companies, including (but not limited to) investments and receiving of funding related to fossil fuels, and publicly release this information.

Marcus Fernihough spoke to the motion saying that resource companies were forces fighting climate change and Curtin had direct relationships with these companies. Marcus said that universities should be at the cutting edge of alternative energy research. Cassidy Pemberton said it was good that that the Guild had a strong stance on this issue. Hameed Mohammad asked about students doing internships and those studying mining courses. Madison Ainsworth said science and engineering students were responsible for securing their own partnerships. Hameed said PHD students worked with companies as required by their supervisors. Marcus said it was more important to save the planet rather than work for resource and mining companies. University should find alternatives for students. Madison said Curtin needed to speed up the process developing partnerships with alternative energy companies.

7.2. Curtin University "Presenting Partner" John Howard

Motion: That the Guild condemns Curtin University's endorsement of John Howard by sponsoring his speaking event.

Marcus Fernihough and Salwa Kilzi said that John Howard's record was despicable in a number of areas. Curtin was endorsing him and his politics.
