- 8.1 The Curtin Student Guild rejects the suspension of Deaglan Godwin and Maddie Clark at the University of Sydney! The right to protest is a core part of freedom of speech!

8.3 Guild Stance on Academic use of Generative AI

Motion: That the Representation Board supports the use of generative AI as a tool for learning among university students and urges Curtin University to:

- Ensure all assessments are of high integrity and hence are not intrinsically hindered by the presence of generative AI
- Mitigate the risk of contract cheating through more authentic and low risk assessment.• Ensure that every unit transition to have at least one element of authentic assessment (that properly considers accessibility needs)
- Ensure all further developed unit outlines contain clear communication surrounding permitted use of generative AI for assessments and that clear Blackboard announcements are in place for current unit outlines that do not contain information on permitted use of generative AI
- Include or adapt a current policy which outlines the procedure to clearly communicate permitted generative AI use to students who do not receive unit outlines (e.g. Research degree students).

• Revisit and redevelop their policy regarding generative AI as the technology improves. This this policy should always be done in consultation with the Curtin Student Guild.
